**49-CFR** (Domestic, UPS, FedEx, BOL, Decs) - **INT'l Air** (Int'l Air, FedEx, UPS, Dec's \*FedEx requires Int'l Air for Domestic air) - **IMDG** (Int'l by vessel)

**SEMINAR METHODOLOGY:** Seminars are taught using a combination of lectures, Visual aids, work projects, and question & answer sessions. Students will learn the 7-step procedure for shipping HAZMAT. Upon passing a written exam participant receives a certification of accomplishment, meeting DOT 172.700 subpart H & 1.5 Int'l Air requirements.

**Seminar Cancellation & Rescheduling Policy:** *Within 14 days (2 weeks)* prior to date: a fee of \$230 for 2-Day or 1-Day seminars & \$330 for 3-day seminar. *Within 7 days (1 week)* prior to date: a fee of ½ the cost will be assessed. *Within 2 Business days* prior to date: a fee of ¾ the cost will be assessed.
